1. Guest Speaker - Cerys Percival and colleagues from ENI

Cerys Percival and colleagues attended the meeting to discuss consultations for an ongoing project, low carbon hydrogen production the HyNet project. Planning for this project was approved in May 2024 however after further investigation ENI need to move the perimeter boundary 250 meters to the East. Work is scheduled to be carried out during February and March 2026 to reduce disruption to the village in the busy summer months. Most of the work will be carried out underground and will not cause a disturbance to residents or the surrounding areas. ENI are working on a community benefit fund for the Llanasa Community Council Ward which is being advocated for by County Councillor Glyn Banks.

On 16/6/25 a consultation period has opened for members of the public to share any comments they may have and will be open until 14/7/25.

 - Councillor Siobhan Cobb raised concerns for Glan yr afon hill.
 ONGOING Clerk has contacted street scene.
- 7. Councillor Siobhan Cobb informed the council that Ysgol Bryn Garth are having issues at school pick up and drop off times with car parking.
 ONGOING Clerk has contacted North Wales Police, they have agreed to do patrols at Ysgol Bryn Garth.
- 8. Clerk provided an update on the electricity supply as the council have not received an invoice since January 2025. Engie say this is still ongoing and an internal error that will not affect the council's supply. Engie are hoping to resolve this issue within the next 10 working days.
- 9. Clerk shared issues with numbering the streetlights as the stickers MEGA are using have not been working.
 - **ONGOING** Clerk has contacted MEGA. Unfortunately, it is not possible to stop the remaining stickers from being completed however MEGA are investigating the batch is not faulty and looking into other options.
- 10. Councillor Elena Charlton-Fleming has received a complaint from residents that a streetlight which has been unused for some time is now working and residents are unhappy with the extra lighting.

RESOLVED – Councillor Elena Charlton-Fleming will contact the resident to inform them the community council are unable to have the streetlight decommissioned.
