1. Guest Speaker – Carl Williams MEGA Electrical

Carl Williams was invited to our meeting to discuss the ongoing project of numbering the streetlights across the ward. The previous project of stickers has not been successful as several stickers have fallen off within the first two weeks of being installed. Carl presented the council with an aluminium plate that will have stickers on them and then screwed onto the wooden lamppost and cable ties used for the non-wooden post. Carl brought along samples for the council to review. The council were very happy with this option. Clerk has spoken to MEGA who have unfortunately said this option is not possible as it will affect the structural integrity of the posts.

ONGOING – MEGA can complete the work if they receive a letter of permission from the owners of the lampposts. Clerk is in the process of arranging this.

5. County Councillors Report

County Councillor Gina Maddison sent her apologies for the meeting and her report via email

"The Council has responded to the appeal by the developers at the Gronant Institute, upholding the original decision. Glyn and I were copied into this.

We have received complaints re the electricity substation at the above, which is within the law, but we are attempting to get the developers to make it more in tune with the surroundings (Glyn knows all about this).Energy Efficiency team, Recycling Service and PCSO have been visiting various warm hubs in the ward and willing to visit any groups.

Shereen Devine of Volunteering Matters is launching a new coffee am for older people at Gwespyr Village Hall every Tuesday till Christmas, 10.30, community councillors warmly invited to attend.

Usual complaints re flytipping /dog excrement/speeding etc. I had some FCC posters printed for various residents, but doubt the offenders take much notice (one shop which put one up told me the offender stood right outside their window with the poster and encouraged the dog to offend, while laughing).

Helped various groups apply for funding pots etc including funding for a youth club at Trelawnyd and a warm hub at Gwespyr Village Hall.

Helped a couple of older people with SPOA assessments.

Trelawnyd Christmas Show Friday 12th December 7pm at the Memorial Hall.

Ysgol Gronant will be acting an intergenerational play Tuesday 25/11 2 pm. Glyn and I went to the original reminiscence session with the children and older people on which the play is based.

Wildflower planting project started on the green spaces in Gronant, joint project between FCC and North Wales Wildlife Trust."

County Councillor Glyn Banks informed the council about the issue with horses in Gronant. This is being investigated by Flintshire County Council.
